# MEMORANDUM OF UNDERSTANDING

BETWEEN

INSTITUT SENI BUDAYA INDONESIA BANDUNG, INDONESIA

AND

GUANGXI NORMAL UNIVERSITY, P.R.CHINA

Institut Seni Budaya Indonesia Bandung, having located at Jl. Buah Batu No. 212, Bandung, Jawa Barat, Indonesia, and Guangxi Normal University, having located at Yucai Road 15, Guilin, Guangxi, P.R.China, hereinafter referred to as "the Parties"; aiming to enhance and develop reciprocal academic cooperation between the Parties; pursuant to the prevailing laws and regulations in their respective countries; have agreed the follows:

## ARTICLE 1

### PURPOSE

The Parties agree to continue their international cooperation in the previous years and will clarify the collaborative roles and responsibilities of each party in a formal written document called Memorandum of Understanding (MoU). The purpose of this MoU is to define collaboration between the Parties in response to development of a globalized world through the field of higher education.



## ARTICLE 2

### SCOPE

The Parties come to agreement to promote mutual academic cooperation in the following scope:

1. Exchange of Faculty Members, Research Scholars and Students;
2. Exchange of lectures/presentations via various activities; including scientific materials, publications and information;
3. Cross recognition working toward Twinning Program (Double Degree Program) and Graduate Degree Program;
4. Join research activities and publications, conferences, academic programs and cultural activities;
5. Joint research projects and joint courses of study, with particular emphasis on internationally funded projects.

## ARTICLE 3

### GENERAL PROVISIONS

1. International Office at Institut Seni Budaya Indonesia Bandung and Office of International Exchanges at Guangxi Normal University shall serve as coordinators of this MoU at their respective universities.
2. Any activities under this MoU resulting in intellectual property shall be subject to the laws and regulations concerning the protection of intellectual property rights in the respective territories of the Parties.
3. All programs, projects and activities created under this MoU will be defined and expressed in separated Memorandum of Agreement (MoA) or as an appendix to an



4. Prior to commencement of any such activities, all relevant aspects, including funding and obligations for both sides will be mutually agreed.

#### **ARTICLE 4**

#### **DISPUTE RESOLUTION**

Any dispute arising from the interpretation and implementation of this MoU shall be settled amicably through consultation or negotiation by the Parties.

#### **ARTICLE 5**

#### **ENTRY INTO FORCE AND TERMINATION**

1. This MoU shall enter into force from the date of signing and seal.
2. This MoU shall be valid for a period of 3 (three) years and afterward it shall be automatically renewed. In the event that either party wishes to terminate the agreement, this must be done in writing to the other party giving at least 6 (six) months notice.
3. The termination of this MoU shall not affect the validity of duration of any arrangements, activities or programs which have been agreed prior to the date of termination of this MoU, unless the Parties agree otherwise.



IN WITNESS WHERE OF, the undersigned, have signed this MoU.

DONE in duplicate in Chinese and English languages, All text is equally authentic. Each of the two parties will keep 1 (one) set of each version. In case of any divergence of interpretation, the English text shall prevail.
